*Candidates with PhD/Master Degree in all concerned discipline of Horticulture/Agriculture are eligible for the post.

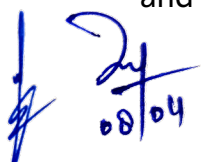
Note: Academic / Research / Extension Score obtained as per Annexure(s) to this Notification shall have a weightage of 80/100 marks (80%) and 20/100 marks (20%) shall be for interview before the prescribed Selection Committee.

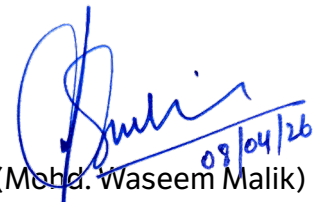

Peer-Reviewed or NAAS rated or UGC-listed Journals (Impact factor to be determined as per Thomson Reuters list):
 - Paper in refereed journals without impact factor = 5 Points

 - Paper with impact factor between 1 and 2 = 15 Points
 - Paper with impact factor between 2 and 5 = 20 Points
 - Paper with impact factor between 5 and 10 = 25 Points
 - Paper with impact factor >10 = 30 Points
 - Two authors: 70% of total value of publication for each author.
 - More than two authors: 70% of total value of publication for the First/Principal/Corresponding author and 30% of total value of publication for each of the joint authors.
- Joint Projects: Principal Investigator and Co-investigator would get 50% each.
- Paper presented if part of edited book or proceeding then it can be claimed only once.
- For joint supervision of research students, the formula shall be 70% of the total score for major advisor and 30% of the total score advisory committee members.
- *For the purpose of calculating research score of the teacher, the combined research score from the categories of 5(b). Policy Document and 6. Invited lectures/Resource Person/Paper presentation shall have an upper capping of thirty percent (30%) of the total research score of the teacher concerned.
- The research & extension score shall be from the minimum of three categories out of seven categories (categories 1 to 7).
- The extension score shall be from the minimum of three categories out of seven categories (categories 1 to 7).Category 7 is the compulsory category for the scientists working in extension system of the university
- Academic/Research/Extension Score = 100
- Academic /research /extension score will have a weightage of 80% (80/100) and interview a weightage of 20% (20/100)
